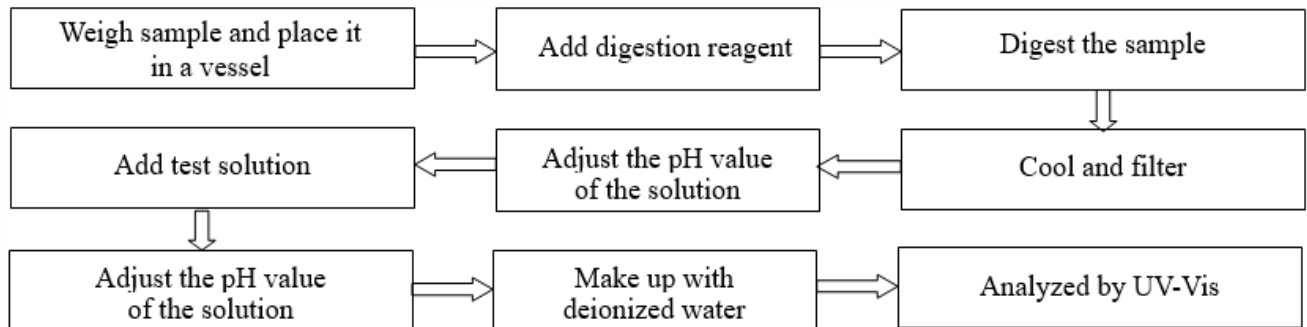

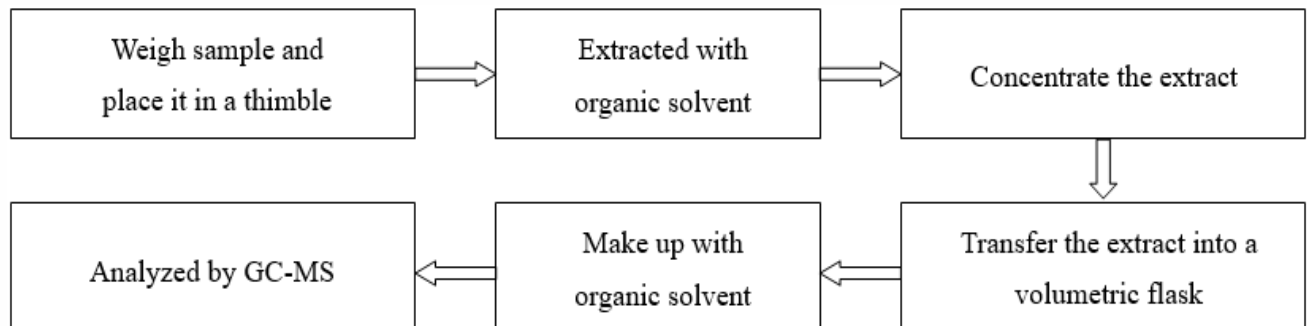
2. Mercury(Hg)

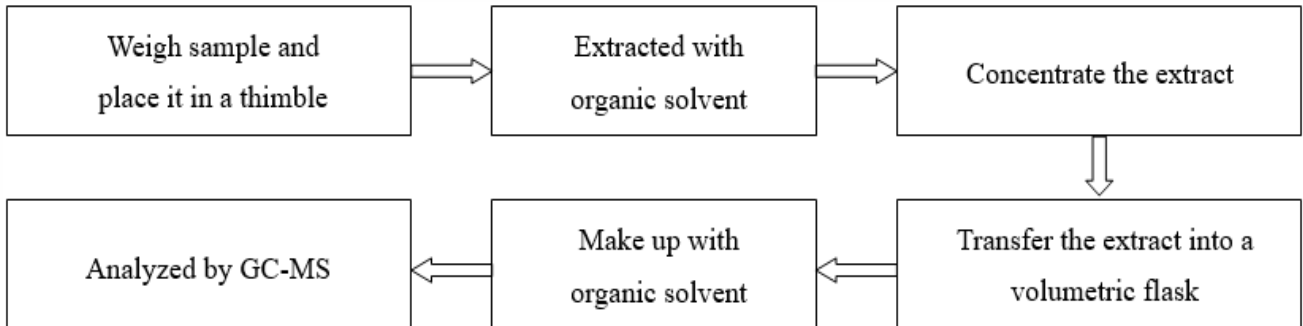

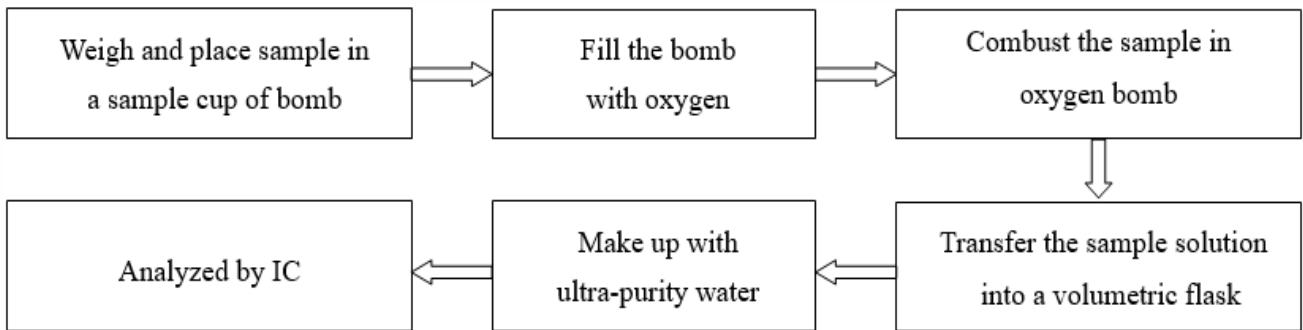

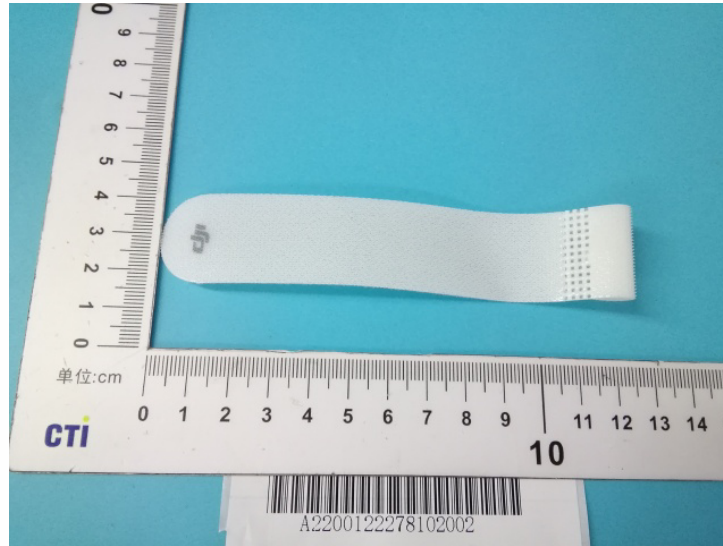
